2. The purpose of the curriculum

Training of specialists capable of solving complex specialized tasks and practical problems in the fields of health care, social services, culture and education, related to physical, social and mental health disorders of individual clients of various ages, groups and communities who, due to illness, trauma or circumstances are limited in their ability to perform everyday tasks while applying the provisions, theories and methods of medical-biological, social, psychological-pedagogical, technological and occupational sciences guided by the principles of client-centeredness, ethics, ensuring the basic needs of each person in occupational activity in everyday life, the right to employment justice, social participation in society and adhering to international standards of education in occupational therapy.

The programme is based on rich theoretical foundations, combining empirical and phenomenological knowledge to develop a deep understanding of the complexity of occupational activity and occupational participation of a person in the context of the environment, to develop skills and abilities to adapt occupational activities and apply them in a therapeutic way in order to restore full life activity in accordance with the desires and needs of the person in the environment, to practice occupational therapy in the natural environment for a person (at work, at home, at school, kindergarten and local community), to work in dialogue with the field of clinical practice and in accordance with current legislation. The programme promotes the value of human diversity, fundamental human rights, including the right to meaningful daily activities, and the dignity and worth of each client. Evidence-based practice in the field of occupational therapy is a strong feature of the programme.

The main focus of the curriculum and specialization

The curriculum "Occupational therapy" is focused on occupational activity as a distinctive element of occupational therapy. The program addresses a unique combination of occupational challenges based on local needs related to human health and well-being, the graduates of which will be able to solve during practical activities. In the curriculum, big emphasis is placed on the study of the impact of health status on occupational participation, methods of changing the occupational lifestyle to promote health and well-being as well as the means of minimizing health risks that hinder people's occupational participation.

Features of the program

The program provides:

- tull-time form of training;
- practice-oriented learning in the laboratory for occupational therapy equipped with grant funds from the Erasmus + KA2 project «Developing an Occupational Therapy study program in Ukraine»), which together with the study occupational therapy promotes the development of students' broader social and communication skills, interaction with clients, the development of professional identity;
- mandatory practices in occupational therapy over 1000 hours in health care, social protection, education, rehabilitation centers in Ukraine and abroad.

Personnel support

Teaching staff of the departments at the Faculty of Human Health and Natural Sciences implements the curriculum. Teaching staff of the Faculty of History, Pedagogy and Psychology, the Faculty of Ukraininan and Foreign Philology, the Faculty of Physics, Mathematics, Economics and Innovative Technologies is involved in teaching certain disciplines, in accordance with their competences and experience.

The practice-oriented nature of the curriculum involves a wide participation of practitioners who correspond to the direction of the program, which strengthens the synergistic connection of theoretical and practical training.

The head of the support group and the teaching staff that ensures the implementation of the curriculum meet the requirements set out in the Licensing Conditions for the staffing of educational activities in the field of higher education.

Logistics

The educational process of the curriculum takes place in classrooms and laboratories equipped with audiovisual equipment and the necessary technical means of teaching. There is free wireless internet access for students in all academic buildings of the University. The computer laboratory where the classes are held is equipped with licensed operating systems and application software packages.

To implement practical skills in occupational therapy and work with simulated patients, the faculty has properly equipped specialized room: Laboratory for occupational therapy, which is equipped with grant funds from the Erasmus + KA2 project "Developing an Occupational Therapy study program in Ukraine" (adaptive kitchen utensils, refrigerator, washing machine, dishwasher, coffee machine); imitation of apartment elements (toilet, bedside toilet, bathroom, bed, wardrobe); household aids; standardized occupational therapy devices: Minnesota Manual Dexterity Test, Grooved Peg Board Dexterity Test, Purdue peg board test (model 320 20), Jamar (5030J1) Hydraulic Hand Dynamometer, Saehan Finger Goniometric Stainless Steel 9 cm - 180 ° per 5 °, etc.

Available educational resources and tools make it possible to conduct research within the priorities of the curriculum.

Clinical practice by graduates is carried out on the basis of specialized treatment and prevention facilities in accordance with current agreements on practice.

Information, educational and methodical provision

Students can use the funds of the university library. The information resources of the library according to the curriculum are formed in accordance with the subject area and modern trends of scientific research in this field. Students can access all printed publications in a variety of languages, including monographs, textbooks, dictionaries, etc. Students can browse the literature using traditional library search tools or use Internet access and a database. Electronic catalogs, domestic and foreign databases, a repository of educational and scientific works help higher education students to obtain the necessary information. Students also use

3. Form of certification of applicants for higher education

The final certification of applicants for the first level of higher education in the specialty 227 "Therapy and Rehabilitation" is carried out in the form of a single state qualification exam.

The Unified State Qualification Exam provides for the assessment of the achievement of learning outcomes defined by the Standard of Higher Education for the first (bachelor's) level in the specialty 227 "Physical Therapy, Occupational Therapy" of the field of knowledge 22 "Health Care", approved by the Order of the Ministry of Education and Science of Ukraine "On Approval of the Standard of Higher Education in the specialty 227 "Physical Therapy, Occupational Therapy" for the first (bachelor's) level of higher education" of December 19, 2018 No. 1419, and the curriculum "Occupational Therapy".

The final certification ends with the issuance of a document of the established form on awarding a bachelor's degree with an educational qualification to a higher education applicant: "Bachelor of Occupational Therapy". Attestation is carried out openly and publicly.
